Breeding Report: Brian Clark

Brian passed out multiple spreadsheets on the genomics analysis of MA/RI lines -- Percent Americanness Some results are surprising

Many other selections are in the testing pipeline -- only about half of the material we submitted has been analyzed..

Some traits are hard to compare across trees because we did some selections 10 years ago; the main stem is likely to have died, but that is less problematic than if it died 1 year after inoculation

Orchard Work:

Granville: 2 lines, with students

Monument Valley 7th and 8th grade students worked with John Meiklejohn. Ratio of 1 student and 1 adult teams were very productive.

Weston: lots of replanting, had very poor survival.

Westboro: put in 4 new plots. Raccoons wiped out most of 1 plot. 2 others had about 40% survival.

Norfolk Aggie: 8 plots planted, 2 plots from seedlings, 6 plots from nuts.; students did a major part of the plot preparation and planting. amount of work. Lisa reported that the orchard has been mowed & weed whacked. They will work on hand weeding this week.

SKLT: is Nanking worth inoculating?

Seed orchards:

-- water system needed fixing Solar system needed fixing

Weeding w/multiple volunteers needed 1 inoculated, 1 selected

Smith 3 inoculated, 3 rated
Pittfield, Granville
Weston, Westboro -- most had inoculations, selections etc.

Breeding orchards: Hawley - Nanking, and several others are ready for inoculations

Getting American nuts for GCOs

If we are going to harvest nuts from American trees, notify Kendra what they are before harvest. Is it in database already? Is it in Treesnap? We need things to line up in the TACF database. Mother tree, pollens etc too.

Very little pollination done this year.

Sampling for genomic testing -- Jamie getting some folks together.

Let Kendra know how many trees you are getting samples of, she will send supplies.

Nominations Committee:

Motion: John Meiklejohn is new chair of the Nominations Committee Motion Passed unanimously

John will contact all Board Members and Officers regarding continuing in their current positions. To nominate new Board Members -- please contact John Meiklejohn Paul W. is working with Michael Novack to learn treasurer's duties.

Michael Novack is transitioning out of Treasurer position. Create new position - VP of Strategic Planning Jamie suggests Michael Novack for the new position John Meiklejohn -- do we need to create a "job description" to focus the person in their duties?

Kendra: Science coordinators are working on breeding plan modifications

Jamie will put together an email on setting up a phone call w/Kendra and what the VP of

Strategic Planning needs to do.

Yvonne suggested that the position needs to be in regular contact w/ other chapters and national discussion on relevant issues, via attending or ZOOM tech.

Tom Saielli has worked on SSA. Kendra will get more information from him when he returns from vacation.

Weaker strain of blight are now being used instead of EP; EP is extremely harsh. Could use on RI trees that are struggling due to poor sites

Report on Abingdon Science Meeting, July 19-20, 2019

Focus of meeting was genomic test results showing 9+ genetic loci involved in blight resistance. Jared presented this last spring

Plan: keep going w/backcross; if some lines are uniformly poor, then use for:

- a.) crossing w/transgenic trees
- b.) cross w/ earlier backcrosses, which are less likely to have lost resistance genes

Brian: if some lines are "of little interest" -- maybe replant those areas in seed orchards w/Graves or Nankings

Requirements for keeping lines separate no longer exist? Need clarification from science staff

Positive selection versus other methods -- Michael

Pillars of science program:

Breeding

Transgenic -- working w/wound-inducible promoter (so OxO gene not always "on")

Hypovirulence

Genomic analyses for better info

Massive numbers of hybrid trees Chapters and Meadowview have done enabled the mapping of resistance trees

CJA -- Chinese Japanese American -- trees surviving in a NH orchard -- Kendra will be going to look at them this week.

Kendra went through the superdonor issues w/hypovirulence

Don Knuss developed this; had a meeting planned w/USDA. USDA did not respond. Takes a while for virus-infected strand to be spread around Still have to treat individual cankers w/hypovirulent strain

Brian: Getting GCOs is fairly important for the long-term future of our program; wild germplasm is slowly disappearing. The original genetic diversity is crucial. Large surviving trees are also important; cruddy bark. Blighted but surviving. Clone? Graft?

GCOs are valuable whether or not we do transgenics. We might end up doing a different cross in the future.

Need someone to manage GCOs. Jamie is asking Mark Meehl to take on GCOs in Massachusetts. Will gather data. Writing it all down is crucial.

If anyone gets requests for a GCO, contact Brian and Mark. GCO's are very flexible. General recommendation. 10 sources, 10 trees/source. Need sources replicated on site. Replicated on other sites even better. These trees may not live forever, will die back etc.

We also want different ecoregions to be conserved. It's important to include underrepresented places/sources.

Nut producing trees are best; can also graft, transplant. Vegetative propagation of root collar sprouts -- Marty Cipollini has documentation of that.

Good management and care onsite by a collaborator is best. They should not be ½ to ¼ mile of another chestnut orchard.

Dave Lent has found lots of pure Americans; will work with Mark on documenting.

Snippets from meeting: plurality of approaches best.

Jamie: people were very generous at the meeting and welcomed him back.

Lots to learn, not an either or. Just the beginning of being able to really measure things. Conversation not over.

CHAPTER OUTREACH:

Kathy and Karen Propose a systematic approach to outreach:

3 Programs yearly for the general public, in Western MA, Central MA and Eastern, MA & Rhode Island. Advertised in regional publications. Topics of General Interest

GOALS: Promote MA/RI Activities, recruit volunteers and partners.

Raise revenue through donations.

Bill Davis and Jim Pelletier have agreed to do programs.

Karen and Kathy requested budget for advertising. No action taken.

TACF has a standardized FAQ card and presentation materials for MA/RI representatives to use for public presentations. Various people give talks already:

Paul W. -- willing to do talks within one hour of his house. Other presenters include Mark Meehl, Yvonne, Kathy, Brad, Jamie, John Meiklejohn. These talks should be recorded in the Chapter Annual Report

Signage:

Karen reported that there is still a need to update signs at various orchards, particularly Westboro. Kathy suggested that Lisa Collins needs one for the Norfolk Aggie in preparation for the AG Expo this fall. Signage needs at other locations was discussed..

There was a discussion on 3 panel signs or single panels are needed.. A list of orchards needing replacement signs must be generated.

Motion: Board authorize no more than \$1000 for A set of 3 panel signs for the Seed Orchards at Westboro and at Norfolk.

Motion: That we provide \$500 to the SKLT toward porta jon, water, and gas. Yvonne to negotiate invoice.

MOTION Passed unanimously

We need a receipt. Invoice the chapter for orchard expenses.

Josh Soojian: contact with forestry grant people: federal grant through state agencies; Has to go to small communities for park plantings

Kendra: staff started developing landscape scale restoration efforts

Had some partners; best materials were planned.

Project put on hold this spring following science review. Will wait until we know what we want to plant out. Potential for a large grant. Applications are regional

Kendra will talk to Josh's contact -- it is great to have a contact for our good trees coming down the pipeline
